The Randolph County Community Arts Center is a participant in West Virginia's Neighborhood Investment Program (NIP). The purpose of NIP is to increase charitable giving to local nonprofit organizations. The program allows 501(c)3 designated charitable organizations (such as your Arts Center) to apply for tax credit vouchers. Businesses and individuals that contribute \$1000 to RCCAC are eligible to receive \$500 in the form of state tax credits. Donors may use the credits to reduce liability for the Corporate Net Income Tax, the Business Franchise tax or the Personal Income Tax.
